Annual Governance Statement for the Governing Body of Richmond Methodist School Academic Year 2019-2020

In accordance with the Government's requirement for all governing bodies, the three core strategic functions of Richmond Methodist School Governing Body are:

- 1. Ensuring clarity of vision, ethos and strategic direction
- 2. Holding the Headteacher to account for the educational performance of the school and its pupils
- 3. Overseeing the financial performance of the school and making sure its money is well spent

Governance arrangements

The Full Governing Body of Richmond Methodist School was reconstituted in May 2017 and is now made up of 13 governors as follows –

- (a) 4 parent governors (of which there is 1 current vacancy)
- (b) 1 Local Authority governor
- (c) 1 staff governor
- (d) 1 Headteacher (ex-officio)
- (d) 3 foundation governors (1 ex-officio)
- (e) 3 co-opted governors (of which there is 1 current vacancy)

We are currently undergoing a further reconstitution and, when concluded, expect that the Full Governing Body will be made up of 12 governors as follows –

- (a) 3 parent governors
- (b) 1 Local Authority governor
- (c) 1 staff governor
- (d) 1 Headteacher (ex-officio)
- (d) 3 foundation governors (1 ex-officio)
- (e) 3 co-opted governors

Attendance record of governors

The Full Governing Body met on five occasions during the school year, the minutes of these meetings are available on the school website.

In 2020-2021 we will meet on 28th September 2020, 23rd November 2020, 25th January 2021, 22nd March 2021, 24th May 2021 and 12th July 2021.

The names of the members of the Governing Body are provided later in this document, as well as a record of their attendance at meetings of the Full Governing Body during the academic year 2019-2020. Their terms of office expiry dates are also provided later in the document.

A review of 2019-2020

Members of the Governing Body have continued to work hard to understand all aspects of their role this year and contribute fully to the work of the school.

During the academic year 2019-20, the Governing Body has held the headteacher to account for the educational performance of the school and the pupils through detailed analysis of pupil data. We received a letter of congratulations from our MP, the Rt Hon Rishi Sunak, offering his congratulations on last year's "brilliant achievement." With the Covid-19 pandemic governors have focused on safeguarding, the engagement of pupils in on-line learning and the support for vulnerable children.

During the academic year 2019-20, the Governing Body has overseen the financial performance of the school and made sure its money is well spent. We have –

- Approved the budget for the year ahead
- Opened nursery provision for 3 year olds
- Invested in full membership of MASS to improve the premises, completed the playground improvements, including the amphitheatre
- Contributed to the appointments of new members of staff and agreed the temporary restructure of the leadership team.

During the academic year 2019-20, the Governing Body has contributed to the vision, ethos and strategic direction of the school by -

- Introduced Pivotal behaviour training
- · Revisited the school vision and embedded this in daily school life
- Communicated "Doing all the good we can" across our school community
- Engaged with social media to engage with our external partners
- Worked collaboratively with local Methodist schools and developed a strong partnership with MAST (Methodist Academies and Schools Trust).

We follow North Yorkshire County Council's advice on school policies and choose to adopt the County's policies. We have also adopted a number of Veritau policies. This year we have reviewed and adopted the following policies –

Appraisal; Assessment Marking and Feedback; Behaviour; Budget Management; Charging & Remissions and Lettings; Child Protection; Complaints Procedure; All GDPR Privacy Notices; Health and Safety; Home Working; Leave; Pay; Records Management; Re-organisation Redundancy and Redeployment; Resolving Issues at Work; Medical; Discipline Conduct and Grievance; Whistleblowing; Early Retirement; Code of Conduct.

These are referenced in the minutes of the Full Governing Body meetings, many statutory policies are published on the school's website.
